OH Screeners

Through May 3, 2020, OH has staffed **4826.25** hours at an approximate investment of **\$241,312** in labor in collaboration with regional employers as we've worked together to flatten the curve.

Updates



- OHMG Occupational Medicine will be open M/W/F beginning May 11 for appointments and walk-in patients. Patients will be served outside those hours by OHMG Urgent Care.
- Urgent Care entrances at HealthPlex's will continue to be closed. Medical Group entrance will be the only door for patients to use. Multicare will use main entrance only.
- All patients and staff will continue to be screened / interviewed at Medical Group entrance.
- Patients will be asked to arrive with own masks. If patients need masks clinic will provide.
- Patients in Urgent Cares will be screened and sent to cars to wait for services.
- All waiting rooms will continue to be arranged to reflect social distances.
- Those patients who travel by public transportation will be provided a restricted area with social distance on first floor to wait for return rides.

Updates



- Radiology services will continue to be by appointment.
- Drive up lab services will continue to be offered.
- HealthPlex's / MultiCare with family practice departments will see patients face to face if requested. All provider patients will be scheduled with a limit of 6 -8 patients per provider per day to enforce patient distance. Patients will remain in cars until appointment time.
